**Subject:** (8) New Indexes to Be Published

**Action:** Firms need to update their security master file accordingly

NYSE Arca will begin publishing the following (8) indexes over the Consolidated Tape on Wednesday, December 1, 2010.

The Consolidated Tape Association (CTA) will publish daily every 15 seconds between approximately 4:00 AM and 5:00 PM ET to Tape B for the Price Return Indexes. The CTA will publish once daily between approximately 5:00 PM and 8:00 PM ET for the Total Return Indexes.

The WilderHill New Energy Global Innovation Index (NEX) is a modified equal-dollar weighted index of publicly traded companies which are active in renewable and low-carbon energy, and which stand to benefit from responses to climate change and energy security concerns. The majority of Index constituents are quoted outside the US, and the Index is rebalanced every March, June, September and December. The Index was created by and is a trademark of WilderHill New Energy Finance, LLC.

The index is calculated in (4) currencies: USD, EUR, GBP, and JPY. There are both Price Return & Total Return Indexes for each currency:

Please be aware that the current calculation agent for the (8) indices is Dow Jones. The calculation will be assumed by NYSE Arca on December 1, 2010. The only change for market data vendors should be the source of the index dissemination.
